SECTION 3- Hazards Identification

*** EMERGENCY OVERVIEW *:** **Aspiration hazard if swallowed.** Can enter the lungs and cause damage. Causes eye and skin irritation. Vapors irritating to eyes and respiratory tract. Avoid contact with skin and clothing. Wash thoroughly after handling.

SECTION 4 – First Aid Measures

FIRST AID - EYE CONTACT: If irritation and or redness develops, move victim away from exposure and into fresh air. Flush eyes with clean water. If symptoms persist seek medical attention. FIRST AID – INHALATION: If respiratory symptoms or other symptoms of exposure develop, move victim away from the source of exposure and into fresh air. If symptoms persist, seek immediate medical attention. If victim is not breathing, immediately start artificial respiration. If breathing difficulties develop, oxygen should be administered by qualified personnel. Seek immediate medical attention.
